A RESOLUTION OF THE UNALASKA CITY COUNCIL APPROVING THE MAYOR'S APPOINTMENT OF AVRIL STRAUB TO THE PARKS, CULTURE AND RECREATION COMMITTEE

Re: Resolution 2024-39: Approving the Mayor's Appointment of Avril Straub to the Parks, Culture & Recreation Committee

SUMMARY: Members of committees and commissions are appointed by the Mayor, subject to approval by the City Council. Due to a vacancy on the PCR Committee following the resignation of Noel Rea, the Mayor has appointed Avril Straub and the appointment is submitted for approval.

PREVIOUS COUNCIL ACTION: Council is provided the opportunity to approve the Mayor's appointments to committees and commissions annually, or as vacancies and appointments occur throughout the year.
